NOTES:

Receiving Funds:

- Interac e-Transfers: Members can receive multiple e-Transfers, up to the per single transaction limit of \$25,000. There is no limit to the total amount a Member can receive within a 1-day, 7-day, or 30-day time frame.
- Me-to-Me Automated Fund Transfers: Members can receive multiple Transfers up to the **per single transaction and 1-day, 7-day, and 30-day limits** posted above.

Sending Funds:

- Interac e-Transfers: Members can send multiple Interac e-Transfers up to the **per single transaction** limit and 1-day, 7-day, and 30-day limits posted above.
- Me-to-Me Automated Fund Transfers: Members can send multiple Me-to-Me Automated Fund Transfers up to the per single transaction limit and 1-day, 7-day, and 30-day limits posted above.

Transfer Limits:

- For both Interac e-Transfers and Me-to-Me Automated Fund Transfers: Limits are automatically reset once the duration is over. For example, if a transaction to send funds by e-Transfer completes on January 5 at 1:00 PM, the 7-day limit will automatically reset at 2:01 PM on January 12.
- Each financial institution sets its own transfer limits. Therefore, transfers into a Member's account may be affected by the limits in place at the sender's Financial Institution.
